





Overview of the Disabled Persons Commission: Background

• • • • • • • • •

The Disabled Persons Commission Act was proclaimed in 1989, with the first Commission being assembled in early 1990. The primary purpose of the Act is to provide for the participation of Nova Scotians with disabilities in the development of government policies and programs which directly relate to or affect them.

The Commission is a mechanism to:

- ensure the concerns of persons with disabilities are promoted within, and considered by, the government, especially in matters of policy and where concerns affect several departments of the government;
- facilitate communication of information on programs and services available to Nova Scotians with disabilities;
- review existing government policies and programs which relate to or affect persons with disabilities to ensure they are appropriate, effective and reflect the needs and concerns of the community.

The Disabled Persons Commission is a provincially legislated body comprised of twelve members, the majority of whom must be persons with a disability or are representative of the community. The remaining members of the Commission are chosen from among government departments which deliver programs that directly affect persons with disabilities. Each Commission member is appointed for a two year term and the Commission members elect the Chairperson, who must be a representative of the community.

In making appointments to the Commission, the Governor-in-Council attempts to ensure that members of the Commission represent the various regions of the province.

Overview of the Disabled Persons Commission: Objectives

The objectives of the Disabled Persons Commission are to:

- Assist the Co-ordinating Committee of Ministers in understanding, and advise the Co-ordinating Committee on the needs and abilities of persons with disabilities;
- Make the general public aware of the needs and abilities of persons with disabilities;
- Make persons with disabilities and the general public aware of government programs that serve persons with disabilities;
- Make the general public aware of what it can do to facilitate the integration of persons with disabilities into the social and economic mainstream of the community.

Overview of the Disabled Persons Commission: Responsibilities

• • • • • • • • •

The Disabled Persons Commission is responsible to the Government of Nova Scotia primarily through the Co-ordinating Committee of Ministers. The Chair of this Co-ordinating Committee is the Minister responsible for reporting on the status of disabled persons, who is also the Minister of Community Services. Membership on the Co-ordinating Committee is comprised of Ministries that have a direct stake in provision of services for persons with disabilities.

The Co-ordinating Committee of Ministers is comprised of:

- Minister of Community Services/ Chair
- Minister of Health
- Minister of Education
- Minister of Service Nova Scotia and Municipal Relations
- Minister of Labour and Workforce Development
- Minister of Transportation and Infrastructure Renewal

Ultimately, the Disabled Persons Commission serves the 20.1% of Nova Scotians who have a disability.

EMPLOYMENT SUPPORT AND INCOME ASSISTANCE (ESIA)

Employment Support Services (ESS) helps people on Income Assistance to become more self-sufficient.

Self-sufficiency means different things to different people. Some people need to work on education, others on job skills. It may mean doing volunteer or part-time work. Self-sufficiency means finding what is right for you at this time, with your background, your family and personal situation, and what jobs are available in your community.

The services depend on your goals and your background. ESS offers some services directly, but also works with other organizations to provide some programs.

You must be a recipient of Income Assistance.

The Income Assistance (IA) program provides people in financial need with assistance with basic needs such as food, rent,

utilities like heat and electricity, and clothing. The program may also help you with other needs such as child care, transportation, prescription drugs, emergency dental care, and eye glasses.

You may be eligible for income assistance if you:

- live in Nova Scotia
- are 19 years of age or older.

You also may be eligible under special circumstances if you are 16 to 18 years of age and are in financial need. That means that your monthly income is less than the amount the ESIA Program allows for basic expenses such as food, rent or mortgage, utilities like heat and electricity, clothing, and taxes.

HOME ADAPTATIONS FOR SENIORS INDEPENDENCE (HASI)

The Home Adaptations for Seniors' Independence (HASI) program helps homeowners pay for home adaptations to extend the time that low-income seniors can live in their own homes independently. HASI provides one-time, non-repayable contributions of up to \$3,500. Funding is provided jointly by the Government of Canada (75%) and the Province of Nova Scotia (25%).

What financial assistance is available?

Assistance in the form of a forgivable loan of up to \$3,500 is available. This loan does not have to be repaid provided that the homeowner agrees to continue to occupy the unit for the duration of the loan forgiveness period. The loan forgiveness period is 6 months. Repayable loans are not available.

LICENSED HOMES FOR SPECIAL CARE

The Services for Persons with Disabilities (SPD) Program provides a continuum of residential support options for individuals with disabilities. The goal is to create a range of residential programs that can support people at various stages of their development and independence.

These settings provide support and supervision in homes with four or more beds. The options for placement in any particular Home for Special Care are limited as to the level(s) of care/ program they provide as per their licensed mandate under the Homes for Special Care Act.

Licensed Homes for Special Care include: Group Homes / Developmental Residences: Group Homes and Developmental Residences provide a continuum of developmental rehabilitation programs for individuals with disabilities within a 4-12 person residential setting. Developmental residences and group homes emphasize the development of inter-personal, community oriented skills, and activities of daily living. Group Homes primarily serve younger persons with one or more of the following types of disabilities: intellectual disability, long-term mental illness, or physical disability. Developmental Residences primarily serve younger adults with an intellectual disability or dual diagnosis.

Residential Care Facilities: Residential Care Facilities provide a residential support option to four or more adults with disabilities who require minimal support and supervision with routine personal-care activities, community skills and activities, and illness supervision. Individuals are provided with limited direct support and do not have major health or behavioural support needs.

Adult Residential Centres: Adult Residential Centres provides long-term structured supports and services to adults with disabilities to enhance their development of interpersonal, community oriented, and activities of daily living skills. Approved staffing is provided on a 24-hour / 7-day a week basis by on-site professional staff.

Regional Rehabilitation Centres: Regional Rehabilitation Centres provide both rehabilitation and developmental programs to adults with disabilities who require an intensive level of support and supervision related to complex behavioral challenges and skill development needs. Approved staffing is provided on a 24 hour / 7-day a week basis by on-site professional staff.

LOW INCOME PRESCRIPTION DRUG COVERAGE (PHARMACARE) FOR CHILDREN

The Nova Scotia government funds a program that provides prescription drug coverage (Pharmacare) for children of low-income families. (This program is sometimes referred to as LIPC: Low income pharmacare for children.) Families pay \$5 per prescription no matter how much the medication costs.

The Department of Community Services also provides Pharmacare coverage for more than 50,000 people who receive assistance from the department including income assistance, services for persons with disabilities and family and community supports.

PROTECTION FOR PERSONS IN CARE

The Protection for Persons in Care Act is an extra safeguard from abuse for patients and residents 16 years of age and older who are receiving care from Nova Scotia's hospitals, residential care facilities, nursing homes, homes for the aged or disabled persons under the Homes for Special Care Act, or group homes or residential centres under the Children and Family Services Act.

Under this act, abuse may be physical, psychological, emotional, sexual, medical, or related to neglect or theft. The act requires health facility administrators and service providers (including staff and volunteers) to promptly report all allegations or instances of abuse.

SPECIAL NEEDS ADOPTION

Special Needs Adoption refers to children for whom it is difficult to find adoptive homes. These children may have learning, behavioural or physical challenges, including delays in physical development, long-term disabilities, or a need for additional medical attention. Some children may need to stay with siblings or be placed in homes that are compatible with their culture (Mi'kmaq Adoption and African Nova Scotian and Bi-racial Heritage Adoption).

Children with special needs are in the permanent care of a Children's Aid Society, Family and Children's Services Agency, or a district office of the Department of Community Services. Most children with special needs are over two years old and have developed relationships with other people. In some cases, continued contact with these people may be important to them.

Financial subsidies may be available based on the needs of the child at the time of placement. The child's home Agency will make the final decision.

TARGET 100 PROGRAM

Target 100 is an initiative that will recruit, train and hire 100 Department of Community Services clients in the co-operative system over the next five years.

How do I access Target 100?

As employment opportunities arise, individuals with the appropriate qualifications will be supported and referred for interviews to fill these positions.

Target 100 will also provide training opportunities to individuals in response to addressing some of these labour market gaps. Individuals that meet the criteria and are a good fit for the opportunity will be interviewed to participate. Information on training opportunities will be shared with Caseworkers.

CONTINUING CARE PROGRAMS

Adult Protection Services

The Department of Health offers help and support for people age 16 or older who are abused or neglected and who cannot physically or mentally protect or care for themselves. This work is guided by the Adult Protection Act (1985). This Act is currently under review.

Home Care

Home care provides service to Nova Scotians of all ages who need care in their homes and communities to help them remain as independent as possible as long as possible. Home care services include home support (such as personal care, respite, and light housekeeping), nursing care (such as dressing changes, catheter care, and intravenous therapy) and home oxygen.

Long Term Care

Long-term care provides accommodation, supervisory care, personal care, and nursing services to individuals who can no longer live independently in the community with family and other supports available.

The Department of Health licenses and approves three types of long-term care facilities. They are:

Community Based Options – Accommodation, supervision and non-nursing level personal care for one to three people in each home. These are unlicensed, but are inspected and approved by the Department of Health.

Residential Care Facilities – Homes for people who need supervision and limited help with personal care. These are licensed and inspected by the Department of Health.

Nursing Homes or Homes for the Aged – Homes for people who need help with personal care and professional nursing care. These are licensed and inspected by the Department of Health.

What is the Nova Scotia Seniors' Pharmacare Program?

The Nova Scotia Seniors' Pharmacare Program is a provincial drug insurance plan that helps seniors with the cost of their prescription drugs. Seniors do not have to join the Pharmacare Program, and not every senior is eligible to join.

Who is eligible? You are eligible to join the program if you:

- are a permanent Nova Scotia resident
- have a valid Nova Scotia Health Card
- are at least 65 years old
- do not have drug coverage through Veterans Affairs Canada, Non-Insured Health Benefits, or any other public or private plan that covers most of your medications and supplies after age 65

MENTAL HEALTH COURT PROGRAM

The Nova Scotia Mental Health Court Program is a voluntary offender-based program for adults (persons 18 years of age and older) who have been charged with a criminal offence and have a mental disorder but are competent to participate in the criminal justice system. For this Program, "mental disorder" means a recognized mental illness, including but not limited to schizophrenia and related disorder, mood disorders, anxiety disorders, developmental (mental) delay, organic (acquired) brain injury or head trauma, and co-occurring mental health and substance use disorders where a mental disorder is the primary disorder.

How is someone referred to the Mental Health Court? The accused will appear in arraignment court where either police, lawyers, Sheriffs, family members, or the accused themselves can recommend that they be referred to the Mental Health Court. The presiding Judge will make the referral.

What happens when an individual is referred? An individual participates in the Mental Health Court on a voluntary basis and agrees to undergo a clinical screening to determine if their mental disorder is contributing to their criminal actions.

If accepted into the Mental Health Court, an assessment will be completed and a support plan developed. This support plan, agreed to by the individual, will include requirements such as participating in programs and attending clinical appointments.

Ideally, it should take 6 weeks from referral to acceptance into the Mental Health Court. Who makes up the court?

The Court has a dedicated team comprised of a nurse, a social worker, a Probation Officer, a Crown Attorney, and a Legal Aid lawyer. There is also a Provincial Court Judge assigned to preside in the Mental Health Court.

PUBLIC TRUSTEE

For administrative purposes, the Public Trustee reports to the Minister of Justice. The Public Trustee manages estates of living persons who need services of a trustee, guardian, attorney or other fiduciary not readily available in the private sector to such living persons administers estates of deceased persons and has standing to apply for grant of administration or administration with will annexed in any case where no grant of probate or administration has been issued may consent to medical or surgical treatment of a mentally incompetent hospital patient when consent cannot be obtained from the patient's guardian, spouse or next-of-kin may act as litigation guardian or representative in litigation for minor, incompetent, deceased, missing or unascertained litigants in respect of whom a court makes representation orders.

You qualify if you have a valid vehicle handicap parking pass issued under the Motor Vehicle Act. The permit may contain special terms and conditions.

The permit does not authorize you to shoot from any public highway. The vehicle being used must be at a complete stop with the motor turned off whenever the firearm is loaded.

ACCESSIBLE PARKING IDENTIFICATION PERMITS AND PLATES

Who is eligible?

Those with a physical disability as described in one of the following statements:

- I have a significant mobility impairment that makes it difficult to walk for more than 50 metres – caused by paralysis, limb amputation, or a heart or lung disease.
- I require the fill-time assistance of a mobility aid such as a wheelchair or walker.
- I am legally blind as defined within the Motor vehicle Regulations.
- I have a temporary mobility impairment caused by a medical condition.

You can apply for your permit either by mail or in person. If you send your application by mail, we will process your application within three business days and mail the permit or plates back to you. If you apply in person, you will get your plates or permit immediately, apply at any registry of motor Vehicles office.

COMMUNITY ACCESS-ABILITY PROGRAM

Community ACCESS-ability Program is one way the Government of Nova Scotia is demonstrating its commitment to equal opportunity and improving access to community facilities and venues for persons with disabilities. Under this program, funds are available for cost shared grants to community groups for accessibility related capital improvements.

Under this program, the provincial Government will make grants of up to two thirds of the direct and indirect costs of renovations, installations, and/or equipment, with the sponsoring organization being responsible for raising at least one third of their improvement project's funding from other sources. The maximum grant available for individual projects is \$10,000. Priority will be given to applications which demonstrate that the improvement proposed is part of an overall plan and commitment to the inclusiveness of persons with disabilities.

Applications for ACCESS-ability Grant funds will be considered any time throughout the duration of the program, subject to funding availability.

HEATING ASSISTANCE REBATE PROGRAM

The Heating Assistance Rebate Program (HARP) provides help to low- and modest-income Nova Scotians with the cost of home heating.

The rebate program will help more than 70,000 Nova Scotians heat their homes, making life more affordable this winter.

This program offers a rebate of up to \$200 for eligible applicants who heat their home with oil, electricity, wood, propane, wood pellets, natural gas or coal.

Single people with an income of \$27,000 or less and families with an annual income of \$42,000 or less qualify for a rebate.

Motor Vehicles - Rebate of Nova Scotia Sales Tax (13%) For Persons with Physiological Impairment

A person who is subject to a physiological impairment and has purchased a passenger vehicle or light truck or van may apply for a rebate of the Nova Scotia Sales Tax (NSST-13%). NSST applies to motor vehicles purchased from persons who are not HST/GST registrants.

The Minister may, upon application authorize a rebate of the Nova Scotia Sales Tax - (not to exceed \$3,000.00) on the purchase of a passenger vehicle, van or truck having a load capacity not exceeding 3/4 ton.

ACCESSIBLE PEDESTRIAN SIGNAL (APS)

Nova Scotia Department of Transportation and Public Works will consider the use of Accessible Pedestrian Signal (APS) indications at signalized intersections on roads owned by the province

An APS is a supplemental device to the pedestrian signal that provides information to visually impaired, persons who are deaf, and others that may benefit from additional sensory prompts, to indicate when it is appropriate to cross the street.

The 'Transportation Association of Canada (TAC) documents 'Manual of Uniform Traffic Control Devices' (MUTCO) and 'Guideline for Understanding, Use and Implementation of Accessible Pedestrian Signals' shall form the basic guidelines for deploying an APS system. Other related documents and standards may be consulted.

ACCESS-A-BUS

Metro Transit's Access-A-Bus service is a shared ride, doorto-door, transit service for persons who are unable to use the conventional transit system due to physical or cognitive disabilities and are declared eligible through a registration process.

The Access-A-Bus service is meant to supplement the Metro Transit fixed route system. Funding is provided by the Halifax Regional Municipality.

You may qualify for the Access-A-Bus service for the following reasons:

- Require use of wheelchair or scooter (users of scooters must transfer to a regular seat).
- Unable to step up or down 35 centimeter (13 inch) step unassisted.
- Unable to walk 175 meters (574 feet) outside unassisted, (one city block).
- Have 20/200 vision or less (legally blind).
- Unable to utilize the existing conventional transit due to cognitive or physical disability. (Use of the low floor buses is permitted).
- Unable to communicate orally or through sign language; this inability must be associated with another significant inability.

CANADA PENSION PLAN – DISABILITY BENEFITS

The Canada Pension Plan (CPP) disability benefit is a monthly payment. It is available to people who contributed recently to the Canada Pension Plan while they worked, and then became unable to work at any job on a regular basis because of a disability. The primary purpose is to replace a portion of employment earnings for people who recently paid into the CPP. There are also benefits for children if at least one parent qualifies for the CPP disability benefit.

A CPP disability benefit is not approved on the basis of which disability or disease you have, but on how the medical condition and its treatment affect your ability to work at any job on a regular basis.

DISABILITY TAX CREDIT

The Disability Tax Credit, administered by Canada Revenue Agency, is a non-refundable tax credit that you can claim on your income tax return if you meet its eligibility requirements. This credit can reduce the amount of tax you have to pay. To make a claim, you must complete and file Form T2201, "Disability Tax Credit Certificate." It must be certified by a medical practitioner. The fact that you get a CPP disability benefit does not necessarily mean that you will get Disability Tax Credit. Please note that these programs have different eligibility criteria.

ENABLING ACCESSIBILITY FUND

As part of a \$45-million, three-year commitment to expand opportunities for people with disabilities, the Enabling Accessibility Fund supports community-based projects across Canada that improve accessibility, reduce barriers, and enable Canadians, regardless of physical ability, to participate in and contribute to their community and the economy. Approved projects will have strong ties to and support from their communities.

There are two kinds of funding under the Enabling Accessibility Fund.

1. Small Projects Enabling Accessibility:

Provides grants of up to \$50,000 for projects to renovate buildings, modify vehicles, and/or make information and communication more accessible.

2. Major Projects Enabling Accessibility:

Provides contribution funding of \$1 million to \$15 million for participatory abilities centres, subject to an agreement with Human Resources and Skills Development Canada.

REGISTERED DISABILITY SAVINGS PLAN

A Registered Disability Savings Plan (RDSP) helps people with disabilities and their families save for the future. Contributions to RDSPs may be supplemented by a Canada Disability Savings Grant and Canada Disability Savings Bond.

Eligible for the Disability Tax Credit (disability amount);

A Canadian resident; and

Under 60 years of age.

If the person is a minor, their parent or legal representative may establish the RDSP for their benefit.
