Disability Tax Credit	 If you have a child with special needs, the Disability Amount Tax Credit (or the 'Disability Amount') is a non-refundable tax credit that can be transferred to a family member who supplied some or all of the basic necessities of life such as food, shelter and clothing to the person. This credit can potentially save \$1,500 a year in income taxes. Who can get this tax credit? Parents or legal guardians, whose child: Has on-going, marked limits in activities of daily living Has cognitive (intellectual), developmental, Physical or mental limitations Once approved, the credit is transferred from the child who qualifies (and who usually has no taxable income) to a parent or other supporting person 	For more info, visit <u>www.cra-arc.gc.ca/benefits/disability-e.html</u> .
